Rules & Regulations

1. Tournament boundaries are Lake Nosbonsing.
2. **No Prefishing or Boating on Lake after 5:00 p.m. on Wednesday, May 28, 2025.**
3. **1st Heat teams: 1-40. Boat check 7:15 - 8:00am**
Fishing Hours are from 8:00 a.m. to 3:00 pm
2nd Heat teams: 41-80. Boat check 8:00- 8:30am
Fishing hours are from 8:30 a.m. to 3:30 pm
3rd Heat teams: 81-120. Boat check 8:30 - 9:00 am
Fishing hours are from 9:00 a.m. to 4:00 pm
4. Boat inspection and check station at the South Shore Boat launch.
5. A maximum of (5) five pike per team may be presented for scoring. No other species of fish may be retained by competitors.
6. Pike must be a minimum of 17" in length (nose to tip of tail) 10 point bonus for live release.
7. Late penalty, one inch per minute. **Competitors must go to the check in boat and drop off their tags before proceeding to the measuring station.** No fishing after check in.
8. Artificial lures only, no live bait. Scent may be used.
9. No trolling through a crowd of stationary boats fishing with the use of their electronic positioning motor.
10. Boats may be inspected anytime during the day. No persons other than actual competitors or a tournament official are allowed in their boats.
11. Live wells or aerated coolers are mandatory.
12. No participant can touch shore during the day, other than at the official checking station.
13. No alcoholic beverages aboard boats.
14. At least one competitor per team must have a valid boaters card and drivers license.
15. All contestants must wear approved life jackets while travelling, other than at trolling or drifting speed.
16. Competitors will be disqualified without refund for any violation of tournament rules. The official's decision will be final.
17. Competitors will be banned from future events for unsportsmanlike conduct including abuse of officials/volunteers in any ways such as social media posts, emails, texts or verbal. The official's decision will be final.
18. In the event of a tie, the winner will be determined by longest fish, including live release bonus.
19. Teams must be paid in full to win the Bonus Tournament.
